1. Name

3. Organisation



4. Rights and obligations / commitment of the participants

4.1. Expenses covered for agents

4.2. Obligations:

- You must fill at least 60% of the agenda. If you do not reach the established minimum, you must justify it and the case will be studied.
- Failure to attend 3 appointments will have the following penalties: the professional will be removed from the rest of the activities included in the MEET Andalucía 2026 and will not participate in the FAM Trip.
- You must participate in all the activities and meals of the program unless it's due to force majeure.

4.3. Commitment:

The industry professionals accepted to participate in MEET Andalucía 2026 must commit to attend the entire event unless it's justified due to force majeure:

- Extreme weather events.
- Own hospital admission or that of a direct family member.
- Death of a direct family member.
- Events considered as such by the courts. In this case, the professional must inform the organisation.

4.4. Registration:

Agencies will be selected and invited by TourSpain. However, if you have not been selected and you are interested in attending, you may fill out the following form to register your interest:


REGISTRATION FORM

- Stop any activity by any Participant that may interfere with or cause a disturbance to any activity or meeting organised during the Event.
- Exclude or remove from the Event any person who does not comply with these Terms and Conditions.
- Exclude or remove from the Event any person who fails to display or adopt general good conduct, and/or fails to display or adopt the professional behaviour that may be expected by the type of Event.
- Cancel companion invitations to sessions due to seating capacity problems.

CANCELLATION OF THE EVENT DUE TO FORCE MAJEURE

In the event that the Organizers cancel the Event due to a case of force majeure recognized by Spanish jurisprudence or defined by the Spanish courts, the Organizers shall immediately inform the Participants.


In this case, the Organizers will not be liable for any loss or damage, but EEA will reimburse the Participants for any amounts they have paid.

Cases of force majeure include:

- a. Events considered as such by the courts.
- b. Events that make the use of the conference venue impossible, regardless of the cause, such as, but not limited to:
 - c. fires, explosions, floods, violent storms or lightning, or damage caused by these.
 - d. damage to technical equipment resulting in the impossibility of using the conference venue.
 - e. decision by a governmental authority to close or requisition the conference venue.

6. Void

In the event that one or more provisions of these Terms and Conditions are determined to be invalid or declared to be invalid under any law or regulation or following a final court decision, the remaining provisions shall remain in force and retain their scope of application.

WEBSITES AND INTELLECTUAL PROPERTY OF THIRD PARTIES


